THIS IS IMPORTANT INFORMATION

If you register your partner with us, it is important you are aware how this will affect your pension. And also know what actions you can take yourself.

You can also arrange something extra for your partner yourself

You have a personal page on **mijnpgbpensioen.nl**. There you can see how much pension your partner receives from us if you predecease him/her. If you consider this amount too low, then you may want to arrange something extra for your partner:

- You can accrue extra partner's pension if you accrue less than 70% partner's pension.
- You can insure an extra surviving dependants (ANW) pension for your partner. If you predecease him/her, your partner will receive this temporary pension until he/she receives a state pension (AOW). This pension is supplementary to the partner's pension.

You do not need to inform us if you get married or register your partnership

If you get married or register your partnership in the Netherlands, we will be informed automatically by your municipality.

N.B. Do you live abroad? You should inform us if you get married or register your partnership.

You do not need to inform us if your partner dies

if your partner dies, we will be informed automatically by your municipality. **N.B.** Do you live abroad? If you live abroad, you should inform us if your partner dies.

You should inform us if you and your partner separate

If you and your partner separate, it is important that you inform us of the separation. This change in your circumstances will affect your pension.

Your partner will retain a claim to some pension if you separate

If you and your partner separate, your partner will retain a claim to a partner's pension. He/she will receive this pension if you predecease him/her. It relates to the partner's pension you have accrued until the time that you separate.
